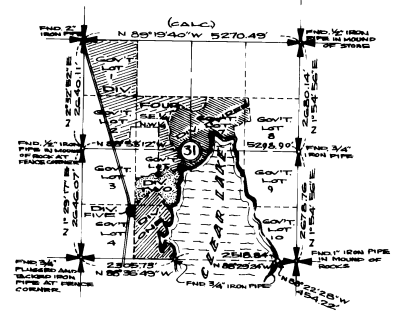


CLEARWOOD
